## Presentment 5

We, the September 2023 Term Grand Jury, received from the District Attorney hand delivered folders from the public on two separate occasions. The folders contained documents with requests of the presiding Grand Jury to determine whether inquiry and/or investigation was to be opened into certain matters. The aforementioned folder contents were identified as follows:

- I. Received at the September 11, 2023 monthly session
- (a) A letter dated September 3, 2023 signed by State Representative Charlice Byrd addressed to Georgia Attorney General Christopher M. Carr with a request to "initiate an immediate inquiry into the provable facts and evidence" to support prosecution of Fulton County District Attorney Fani T. Willis for violation of her statutory oath;
- (b) A letter dated September 3, 2023 signed by State Representative Charlice Byrd addressed to Georgia Governor Brian Kemp with a request to "initiate an immediate inquiry into the provable facts and evidence" to support prosecution of Fulton County District Attorney Fani T. Willis for violation of her statutory oath;
- (c) A document entitled "PETITION TO THE CHEROKEE COUNTY GRAND JURY 2023 SEPTEMBER TERM FOR A CIVIL AND CRIMINAL INQUIRY" regarding the "MASTER SOLUTION AND SERVICES AGREEMENT BY AND BETWEEEN DOMINION VOTING SYSTEMS, INC. as Contractor (Dominion), and SECRETARY OF STATE OF THE STATE OF GEORGIA as State (Brad Raffensperger) seeking "the

inquisition of this Honorable Article I Court of Inquiry as to the void and void ab initio status of the Contract in question."

# II. Received at the October 13, 2023 monthly session

- (a) A letter dated September 20, 2023 signed by State Representative Charlice Byrd addressed to Grand Jury Foreperson Will Rownd with a request to set "a date and time certain" for the purpose of presentation of "our testimony as upon the merits of our submissions" to the grand jurors;
- (b) Documentation from the Georgia Government Transparency and Campaign Finance Commission purportedly showing outstanding fees owed by Fani T. Willis to the State of Georgia in the amount of \$125;
- (c) A letter dated October 4, 2023 signed by State Representative Charlice Byrd addressed to Chairman Randy McGinley of the Prosecuting Attorneys Qualifications Commission requesting a formal review of District Attorney Fani T. Willis for violation of her oath of office;
- (d) A copy of Oath of District Attorney and Loyalty Oath of Fani T. Willis;
- (e) Identical copy of the September 3, 2023 letter referenced above addressed to Attorney General Christopher M. Carr.

The District Attorney additionally provided the September 2023 Term Grand Jury with applicable Georgia law which outlines the duties and authority of the grand jury when said body elects to undertake an independent investigation:

"...the grand jury shall, whenever deemed necessary by eight or more of its members, appoint a committee of its members to inspect or investigate any county office or county public building or any public authority of the county or the office of any county officer, any court or court official of the county, the county board of education, or the county school superintendent or any of the records, accounts, property, or operations of any of the foregoing." O.C.G.A. § 15-12-71

After review of the contents of said folders and applicable Georgia law, we, the September 2023 Term Grand Jury, find that the Cherokee County Grand Jury lacks authority to investigate any matter concerning Fulton County District Attorney Fani T. Willis in her official capacity, as District Attorney Willis is a Constitutional officer of the State of Georgia and the Office of the Fulton County District Attorney is not located within Cherokee County, Georgia. We, the Grand Jury, conclude that, pursuant to O.C.G.A. § 15-12-71, the Cherokee County Grand Jury does not have legal authority to inspect any records, accounts, property or operations outside of Cherokee County, Georgia.

We, the September 2023 Term Grand Jury, additionally conclude that the Cherokee County Grand Jury lacks jurisdiction to investigate any contract that exists between the State of Georgia and Dominion Voting Systems, Inc., as the legal investigative authority of the Cherokee County Grand Jury does not extend to any state governmental office or official.

After collective discussion and careful consideration, we, the September 2023 Term Grand Jury, declined to pursue any investigation into the use of Dominion voting machines in Cherokee County elections.

## Presentment 6

We, the September 2023 Term Grand Jury, express our sincere appreciation to Clerk of Courts Patty Baker for her informative presentation on the operations of the Cherokee County Board of Equalization.

We, the September 2023 Term Grand Jury, pursuant to O.C.G.A. §48-5-311, having received notice from the Board of Equalization, and after publication by the Clerk of Superior Court in compliance with O.C.G.A. §15-12-81, received and reviewed the submitted applications for the vacant positions on the Cherokee County Board of Equalization. All applicants were thereafter interviewed by the Grand Jury on December 11, 2023.
