**APPLICATION FOR EROSION & SEDIMENTATION
CONTROL PERMIT FEE \$75.00 RENEWAL FEE \$25.00**

Please read carefully before applying for this permit.

1. This application is not a permit to begin work, construction, earthmoving, or land disturbance on any site.
2. This application is not for commercial projects/sites. This application is for single family residential or residentially zoned parcels that are not being rezoned for development.
3. This permit application is not for projects that exceed an acre of disturbed area. If your project will exceed an acre of disturbed area, then you must follow the land disturbance permit application requirements.
4. Once this application is submitted and the fee is paid, contact the Cherokee County Stormwater Management Department (678-493-6060) to schedule a meeting with an inspector.
5. A permit card will be issued at the job site when the erosion & sedimentation control devices are in place and in compliance with the Cherokee County Erosion and Sedimentation Control Ordinance.
6. Written permission from Environmental Health or a valid septic permit is required to be attached to this application if the property utilizes or will utilize an on-site sewage management system.
7. A valid driveway permit must be attached to this application if the application is to be used for accessing property from a county Right of Way.
8. **The permit will expire 30 days after the permit card is provided to the applicant. If your permit has not been issued within 30 days of the application date, the application will be automatically voided and you will have to contact dsc@cherokeega.com to determine if your application fee can be refunded.**
