# EXECUTIVE SUMMARY

The Cherokee County Board of Commissioners has a unique opportunity to utilize the funds received from the American Rescue Plan Act to help the County, its citizens and businesses to recover from the Coronavirus or COVID-19 Pandemic. The County has used the funds to aid with the following broad initiatives:

- Job Training & Retraining Programs
- Business Recovery Programs
- Facility Improvements
- Judicial System Enhancements
- Make Up Lost Revenues
- Health and Safety Initiatives
- Technology Improvements
- Homelessness & Community Needs

To date, Cherokee County has utilized and/or allocated its entire allotment for the initiatives listed above.

More details on programs and projects in each category are discussed in the Project Inventory portion of this report.

## Use of Funds

Cherokee County has allocated 100 percent of its awarded funding and expended 73 percent to date. Funding was appropriated across all seven expenditure categories to help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn. Specific strategies to maximize programmatic impact and effective, efficient, and equitable outcomes continue to be determined. Cherokee County is promoting projects in each of the following Expenditure Categories:

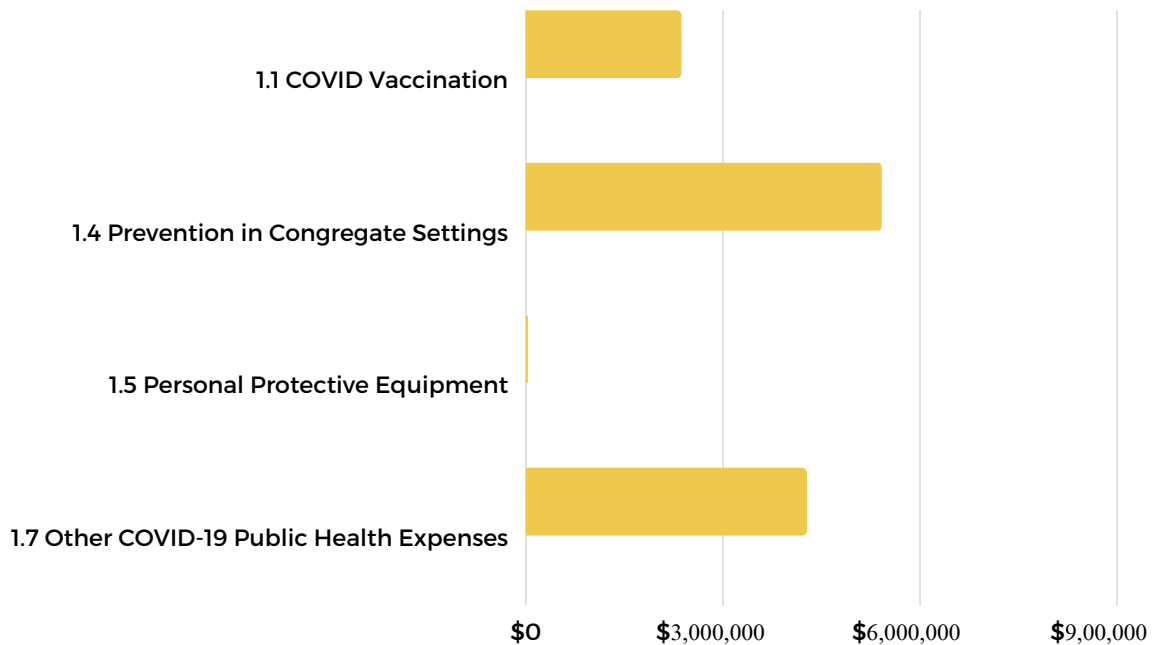

**PUBLIC HEALTH**

Public health was at the forefront of decision making when allocating State and Local Fiscal Recovery funding through the American Rescue Plan Act. Cherokee County identified areas that could be improved upon and protecting the frontline workers and the general public from the COVID-19 virus. The County Administration Building served as a mass vaccination site through a partnership with the local hospital. To allow for social distancing, the County leased space for the court system and purchased an existing facility for elections. Personal Protective Equipment was purchased for the county coroner's office, and medical equipment and transport vehicles were included. The County also provided over half a million dollars to a non-profit provider of medical and dental services to low income residents.

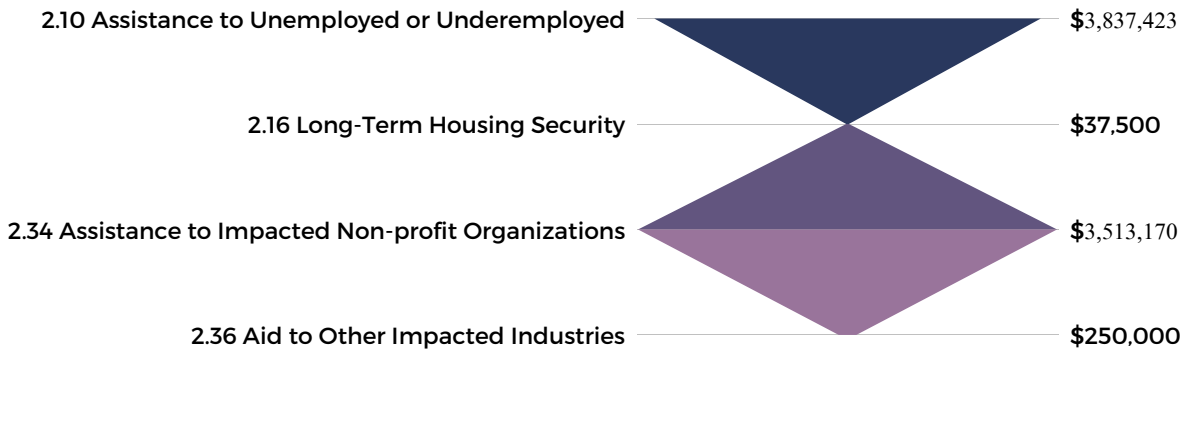
# NEGATIVE ECONOMIC IMPACTS



Funding allocated for assistance to households, businesses and non-profits under Negative Economic Impacts puts focus on identifying and serving the needs of the underprivileged and helping people get back to work through job assistance and training programs. The County has allocated \$5-million for non-profits to help provide relief in housing expenses, homelessness and provide everyday assistance to those in need. The County has issued two rounds of solicitations and made awards to 12 non-profits. The County has also partnered with the Cherokee Office of Economic Development and allocated \$2.6-million to assist local businesses that experienced a negative economic impact due to COVID-19 and provide job training assistance to under and unemployed workers. The final project with COED is the installation of a new sewer line from Ball Ground to Canton in order to expand the infrastructure to allow new industrial development along the northern corridor of the County.

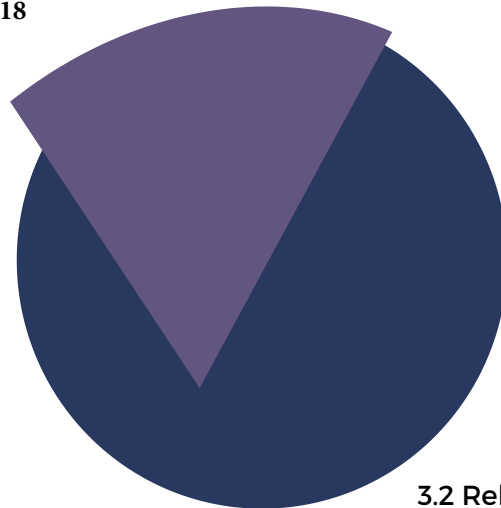
# PUBLIC SECTOR CAPACITY

The Public Sector, especially Court Services, faced a backlog during the COVID-19 pandemic, fueled by shutdowns ordered by the Georgia Supreme Court Chief Justice. Cherokee County has allocated about \$5.9 million to provide additional space and hire more personnel to process existing and new cases in the court system. Enhancing Service Delivery Effectiveness efforts include a secure, records storage upgrade/expansion for the County Clerk Clerk of Courts and Sheriff's Office, the addition of a code enforcement module, body camera system for the Sheriff's Office, upgrades to both the camera system and duress system for the Sheriff's Office.

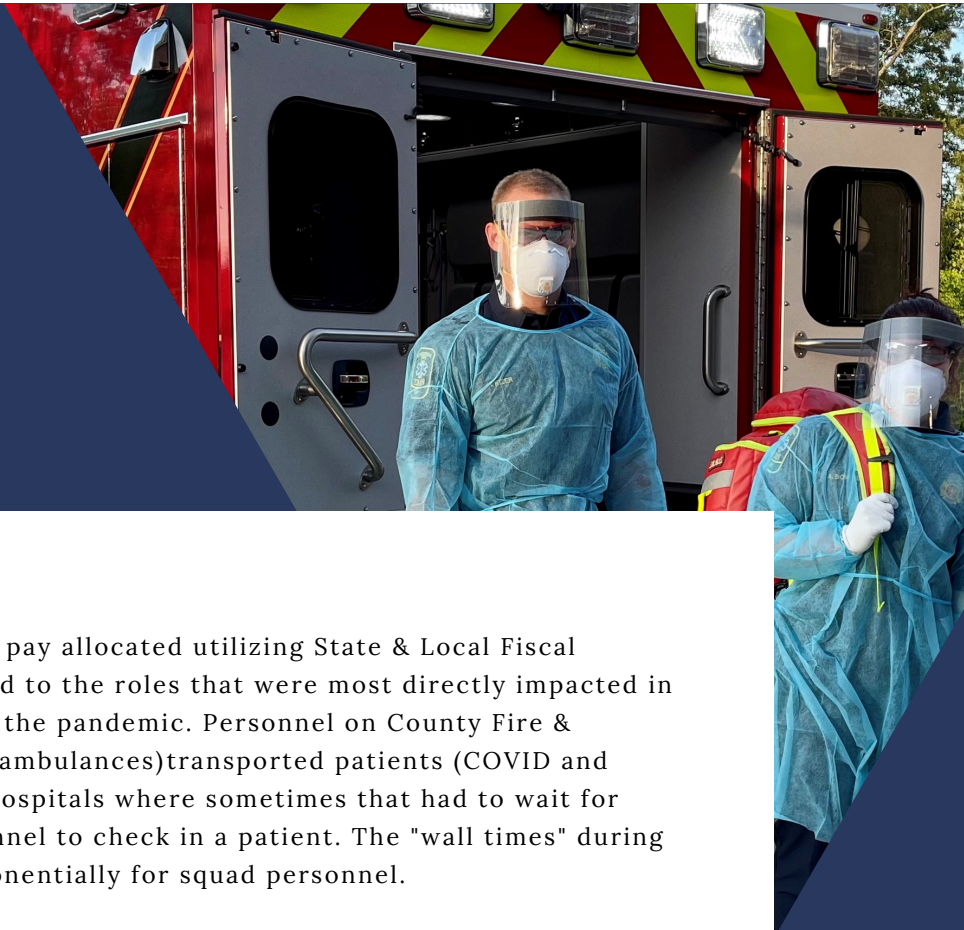

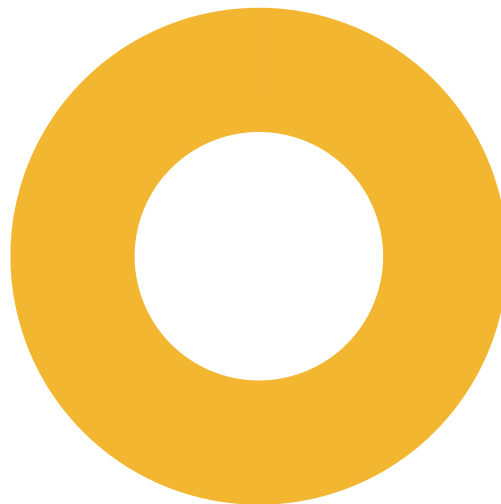

# PREMIUM PAY



The majority of the premium pay allocated utilizing State & Local Fiscal Recovery Funding was applied to the roles that were most directly impacted in their day-to-day jobs during the pandemic. Personnel on County Fire & Emergency Services squads (ambulances) transported patients (COVID and non-COVID related) to area hospitals where sometimes that had to wait for hours for the hospital personnel to check in a patient. The "wall times" during the pandemic increased exponentially for squad personnel.

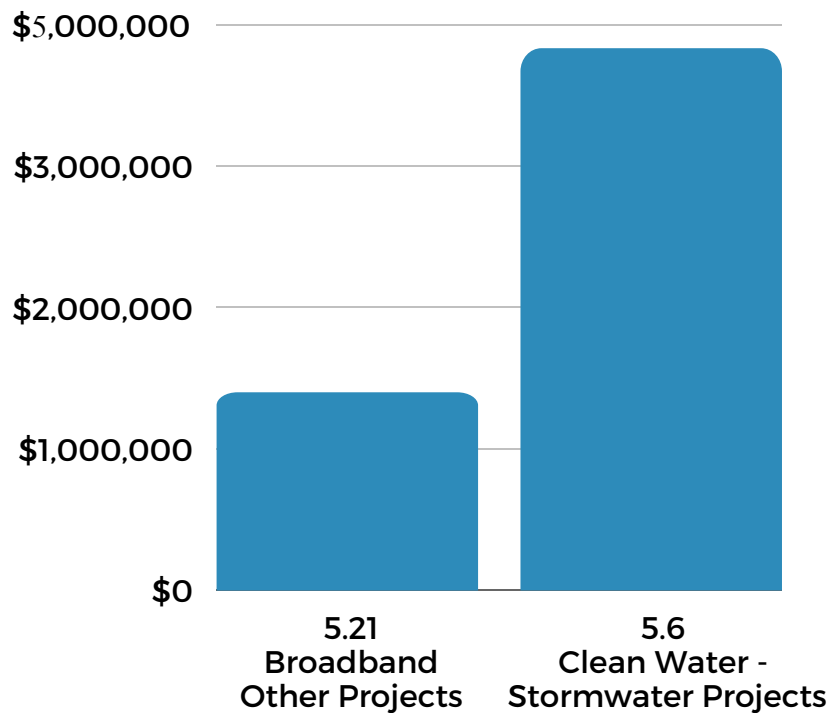

# INFRASTRUCTURE

Cherokee County identified two segments of infrastructure projects including cybersecurity and stormwater. The County allocated about \$1.4 million for infrastructure improvements and increasing bandwidth to protect the County's digital infrastructure from cybersecurity threats, including firewalls additional offline storage for the Justice Center and main administration building, and encryption solutions. Nearly \$4.9 million was allocated for multiple stormwater projects in unincorporated Cherokee County to protect public and personal property, as well the County's waterways.
