Community Development Fee Schedule

Building Department

Cherokee County has adopted the ICC Building Valuation Construction Cost for permitting fee calculations.

The Square Foot Construction Costs from the August ICC Building Valuation Data publication shall be applied to calculate Construction Costs beginning October 1st of each calendar year. The ICC Construction Cost will vary by occupancy use group and the type of construction.

Certain building types are not addressed by the ICC Construction Cost table. In this case the Building Official may use another national index, such as R.S. Means Square Foot Costs, current edition, or data collected periodically by Cherokee County to establish a Construction Cost.

A permit applicant may also request a custom Construction Cost from the Building Official by submitting documentation to support the request. The Building Official may have up to 5 business days to determine a custom Construction Cost or reject the request.

Construction Cost per sq. ft is calculated from ICC Square Foot Construction Cost X Regional Factor (see Building Valuation Data sheet for amounts)

Commercial Building Permits

(New buildings, additions and industrialized buildings)

Sq.ft. Area X Construction Cost per sq.ft. X Department Multiplier = Permit Fee

Manufactured Home Location Permits

(Only HUD homes are permitted in Cherokee County)

Sq.ft. Area X Construction Cost per sq.ft. X Department Multiplier = Permit Fee

Swimming Pool Permits

(Residential & Commercial)

Sq.ft. Area of Water X Construction Cost per sq.ft. X Department Multiplier = Permit Fee

Renovations

Sq.ft. Area X Construction Cost per sq.ft. X Department Multiplier = Permit Fee

Residential = 0.0035 (\$3.50 per square foot)

Commercial = 0.004 (\$4.00 per square foot)

Budget values, percentages of fee support for each department and the total construction value may be updated from time to time by the Board of Commissioners, which will change the dept. multiplier.
